

THE PRESIDENT OF THE REPUBLIC

Considering:

That it has been noticed that the telegraphic, postal and fiscal seal are been extracted of the respective documents and washed to be put in circulation again. Regarding the above mentioned and in use of his facultities.

Decreets:

Art. 1. It is commanded to reseal all the telegraphic, postal and fiscal seals, with the inscription "RESEAL 1927"

120 The seals in existence at the fiscal offices of the Republic, will be substituted with the resealed.

Art. 2. From the 15th of May on, will be valueless the fiscal seals which do not bear the reseal refered in this Decree.

Art. 3. The Inspector of Fiscal Species is commissioned to supervise the resealing of the seals at the Nacional Printing House and to exchange the seals in use for the resealed ones, in all the fiscal offices of the Republic.

Given in Managua- Palace of the Executive, at the 28 days of the month of April of 1927- Adolfo Diaz. The Minister of Finance- F. Guzman.

THE PRESIDENT OF THE REPUBLIC

DECREES:

Art.1. Custom seals are put in circulation, orange color with a value of C\$0.10 each one, that the Government received from abroad.

Art. 2. To command to reseal in the Nacional Printing House, with black ink, 150.000 custom seals of C\$0.10, to collect the tax on imported cigarrrets, with the following inscription: Imp. S/Cigarrillos Int. Nicaragua. (Tax on Imported Cigarrets Nicaragua)

Given in Managua, at the Presidencial House, at the first of June of 1931. J. M. Moncada- The Minister of Finance. Ant.Barberena.

Considering

That it has been found that the Telegraphic, Postal and Fiscal Stamps are being removed from respective documents and mail and are being washed or cleaned of the cancellations and then put in circulation again. Regarding the above and using his facilities

decrees

- Art. 1 - It is ordered that all Telegraph, Postal, and Fiscal Stamps be surcharged "RESELLO 1927". The stamps in existence at the various offices of the Republic will be exchanged for the new stamps.
- Art. 2 - After May 15 all stamps without the new surcharge will be valueless.
- Art. 3 - The Inspector of Postage Stamps is ordered to supervise the revalueing of the stamps at the National Printing Office and to exchange the stamps now in use for the new revalued ones in all the offices of the Republic.

Considering:

144 1st- That there is in existence at the Warehouse of Fiscal Species certain amount of Postal Stamps, Telegraphic Seals and Fiscal Seals of old issuance, either resealed or without seal;

147 2nd- That there are besides, a great existence of the mentioned species, of recent issuance, that were brought in with the only purpose of exchanging the old issues;

3rd- That the fact of having acumulated in the warehouse a great existence of species of the same kind and values, but of different colors ones, and resealed the others, denounces lack of seriousness and uniformity in the handling of the sames, impairs the inventory taking and balances in the General Warehouse and it is liable to fraudulence practices,

Decrees:

1st- From this date on are totally valueless and out of circulation all the postal species of old issuance or resealed, including those of air mail; the fiscal seals of old issuance or resealed;

2nd- The following kinds of species of the difference values and colors of the new issuance, will substitute all those ~~and~~ canceled by this decree;
