THE PRESIDENT OF THE REPUBLIC

Considering

That the postage stamps now available with the surcharge "1927" and "1928" do not offer the necessary guarantees to the Treasury, and in order to safeguard the interests of the fiscal department it is found necessary to withdraw them from circulation,

decrees:

I. - That from the 15th of June next the said specie are to be considered without any value, and they are to be replaced by those which the Govt. will place in the General Treasury and Administration de Rentas de la Repub. The patentees or bonafide holders of such specie are obliged to present them at the respective offices for replacement. Individuals holding any of such stamps who are unable to show legitimate ownership will suffer the consequences imposed by the law of "Paper Sellado & Timbres" of 1917.

II. - The Minister de Hacienda is commissioned to order the surcharging by the National Printing Plant of the specie described as follows:

With the inscription "Correos de 1928"...

537,300 postage stamps of 1/2 centavo remaining without surcharge in the

Almaoen de Especies Fiscales.

400,000 postage stamps of 1 centavo etc. etc.  
374,000 etc. etc.

The postage stamps remaining in the Almaoen de Especies Fiscales after the above quantities have been withdrawn, as well as the onesto be received for replacement are all to be packed and sealed and left in possession of the Govt. pending decision as to their convenient disposal.

That the postal stamps of C\$0.01/2, C\$0.01 and C\$0.02 are exhausted, same as the C\$0.20 sealed paper, having to provide to the concerned employees of such species,

Decreases:

To command to reseal with the following values and with the inscription "Post 1929", the following species:

136 150.000 postal stamps of C\$0.01/2 for same value as the resealed 1928.

200.000 of C\$0.01 for the telegraphic seals of R. de C. of C\$0.05.

250.000 of C\$0.02 for the of idem, idem (same, same)

20.000 sheets of sealed paper of C\$0.20, for the value of C\$0.40.

This last specie will bear across the official word "RESEALED 1929".

Decrees:

Art.1. The surcharging "Resello de 1928" of the following stocks existing in the Almacoen Central de Especies Fiscales:

50,000 fiscal stamps of C\$0.02 each

The same operation to be effected on 300,000 postal stamps "R de C" of 1 c.

Art.II. Once the above stamps have been surcharged they will be placed on sale to the public, and the Tribunal Supremo de Cuentas will then be authorized to give full details of the operation to the General Treasurer.

- Art. I. The modification of the executive decree of the 4th inst. with respect to the following points referred to in Art. 1 of the same, that the fiscal stamps of the denominations and quantities to be surcharged, instead of bearing the inscription "Resello de 1928", the surcharge will read: "Fiscales-Resello de 1928".
- Art. II. With reference to the 300,000 postage stamps R. de C. of 1c which are also to be surcharged as above, same will bear the inscription "Resello de 1928".
